**WHEREAS**, Daniel B. Leeper served with distinction and dedication as a member of the Board of County Commissioners; and

**WHEREAS**, Daniel B. Leeper obtained his Certified County Commissioner and Advanced County Commissioner certifications through the Florida Association of Counties, further demonstrating his commitment to his role as County Commissioner; and

**WHEREAS**, Daniel B. Leeper has ably represented Nassau County in many forums and arenas and has been an outstanding asset to Nassau County; and

**WHEREAS**, during his time as a County Commissioner, Daniel B. Leeper was appointed by his colleges to serve as Vice Chairman of the Board from January 1 through July 8, 2012; from January 1 through November 20, 2016; and from January 1 through December 31, 2019. He also served as Chairman of the Board from July 9, 2012 through November 30, 2013; from April 21, 2016 through December 31, 2017; and from January 1, 2020 through November 16, 2020; and


**WHEREAS**, Daniel B. Leeper always afforded every citizen who has appeared before the Board of County Commissioners with respect and fairness; and




