COVID-19 Vaccination Efforts

OneNassau is the result of a Joint Partnership between the Nassau County Department Health, Nassau County Emergency Management, and the Board of County Commissioners. OneNassau's mission is to help the community before, during and after disasters.

OneNassau has worked diligently to dissiminate information related to COVID-19 to the residents of Nassau County. This includes daily updates on cases, as well coordinating vaccination events and scheduling appointments for individual vaccinations.

In the month of April, 63 Board of County Commissioner employees dedicated 424 manhours working at vaccination events.

As of April 30, 2021, a total of 33,784 vaccines had been administered. Of those, 5,343 had completed their first dose and 28,441 had completed both doses.



 - How to use the info you've learn to plant your own seeds






"Just Above Water: Florida Folk Art" will be on display at the Fernandina Library from May 1st -Oct. 30th.

Will Hardee Storm Drain Repair Project Complete



Public Works has been working on an underground storm drain system repair since early February which included removing and replacing the existing failing metal culverts; removal and replacement of approximately 1,000 linear feet of sidewalk; removal and reset of the concrete drainage inlet; repair of damaged structures; dressing the area to promote proper drainage; and sod for the disturbed areas.

Westside Regional Park Update


The consultant, Prosser, Inc., worked to prepare three conceptual plans for the Westside Regional Park. These plans were designed based on input from the public gathered from surveys and community meetings, along with input from professional staff.

The plans are expected to be presented to the Board of County Commissioners in late May, along with a stafff recommendation. Once the conceptual plan has been confirmed, the project will move into the engineering phase with an anticipated timeline to begin construction on Phase One in early 2022.


Hazardous Waste Recycling Event



Code Enforcement

Success Story

In March 2021, Code Enforcement received a complaint about a property being in violation of Ordinance No. 2015-10, Section 6.01(3), General Nuissance Affecting Public Health.

Upon an inspection by Code Enforcement Officer, Robert Bostick, it was determined that this was rental property. The property management company stated that the tenant had moved and placed items by the road thinking the garbage company would pick them up. They also stated that they would clean the items up.

At the beginning of April 2021, Code Enforcement received notification that all the debris was removed from the property. Officer Bostick did a follow-up inspection and determined that the property was in compliance and is no longer a health or safety hazard for Nassau County residents.
