Nassau County, Florida July 21, 2022 – On behalf of CSX, the Nassau County Road Department is issuing a Notice of Intent to Begin Construction on the following railroad crossing due to repairs needed. Crossing will be closed between 2 to 5 days, except one way in/out crossings, varying on repairs needed:

Ratliff Road in Callahan, FL – August 2 at 8:00 am to August 6 at 5:00 pm -- Proposed Detour: US1 to US301 to Thomas Creek Road to Ratliff Road

Private Crossing (Located at end of Artesian Blvd.) in Callahan, FL – August 4 at 8:00 am to August 5 at 8:00 am. One way in and Out

Pickett Street in Callahan, FL – August 8 at 8:00 am to August 12 at 5:00 pm -- Proposed Detour: US1 to US301 to Pickett Street

River Road (Brandies Ave) in Callahan, FL – August 10 at 8:00 am to August 14 at 5:00 pm- Proposed Detour: Old Dixie Hwy to Bypass Road to River Road
