A total of 181 households participated in the 2019 Nassau County HHW Collection event held at the Nassau County Solid Waste Department hosted jointly by the Alachua County Environmental Protection Department and the Nassau County Board of County Commissioners. This represents approximately 362 residents participating in the event with a combined total of 10.42 Tons of material received for proper classification and disposal. In addition, this year in conjunction with our media company Uppercase and the Alachua County Communications office we promoted the collection event through social media, government websites, as well as print media.
